ORDINANCE NO. 606-2022

AN ORDINANCE AMENDING THE MASTER PLAN FOR CHURCHILL II SUBDIVISION, A PLANNED UNIT DEVELOPMENT

WHEREAS, the developer of Churchill II Subdivision, a Planned Unit Development (hereinafter referred to as "Churchill PUD"), has requested certain amendments to the Master Plan be approved for the development; and

WHEREAS, the Planning Commission of the City of Spanish Fort held a meeting on September 12, 2022, and the City Council of the City of Spanish Fort held a meeting on October 17, 2022, for the purpose of receiving public comments on the proposed amendments to the Churchill II Subdivision PUD Master Plan.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SPANISH FORT, ALABAMA, AS FOLLOWS:

SECTION 1. Amendment to Churchill II Subdivision, a Planned Unit Development.

The Churchill PUD contains certain property which is described as set forth in Exhibit 1. The approved Master Plan for Churchill II, as amended, is set forth in Exhibit 2. The Master Plan for Churchill II Subdivision, a Planned Unit Development, is hereby amended to read as set forth in the attached legal description in Exhibit 1, and Master Plan as modified and amended is attached as Exhibit 3.

SECTION 2. Repealer Clause.

Except as expressly amended herein, all terms and provisions contained in Ordinance No. 51-96, as amended, and the approved Churchill II Subdivision, a Planned Unit Development shall remain in full force and effect.

SECTION 3. Severability Clause.

If any part, section or subdivision of this Ordinance shall be held unconstitutional or invalid for any reason, such holding shall not be construed to invalidate or impair the remainder of this Ordinance, which shall continue in full force and effect notwithstanding such holding.


