

**ORDINANCE NO. 617-2023**

**AN ORDINANCE AMENDING ORDINANCE NO. 51-96 OF THE CITY OF SPANISH FORT ESTABLISHING THE ZONING CLASSIFICATION OF CERTAIN PROPERTY AS B-3, GENERAL BUSINESS DISTRICT**

**WHEREAS**, the owner of the property, Carrel E. Cometti, Jr., has requested that property described below be pre-zoned in accordance with Ala. Code § 11-52-85 (1975); and

**WHEREAS**, the owner has submitted a request in writing that the subject property be zoned B-3, General Business District, upon its annexation into the corporate limits of the City of Spanish Fort; and

**WHEREAS**, the Planning Commission of the City of Spanish Fort, Alabama, held a meeting on December 12, 2022, and the City Council of the City of Spanish Fort held a meeting on January 3, 2023, for the purpose of receiving public comments on the proposed zoning classification.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SPANISH FORT, ALABAMA, AS FOLLOWS:**

**SECTION 1. Establishment of Zoning Classification.**

In accordance with Ala. Code § 11-52-85 (1975), upon annexation of that certain property bearing Baldwin County Tax Parcel No. 05-32-05-22-0-000-080.000 into the corporate limits of the City of Spanish Fort, said property being more particularly described as set forth in the legal description in Exhibit "A" which is attached hereto and made a part of this Ordinance as though set forth fully herein, the said property shall be zoned B-3, General Business District.

**SECTION 2. Change in Zoning Map.**

The official zoning map for the City of Spanish Fort is hereby amended, changed or altered to reflect the establishment of the zoning classification of B-3, General Business District, on the above-referenced property.

**SECTION 3. Repealer Clause.**

Any ordinance heretofore adopted by the City Council of the City of Spanish Fort, Alabama, which is in conflict with this Ordinance is hereby repealed to the extent of such conflict. Except as expressly amended herein, all terms and provisions contained in Ordinance No. 51-96, as amended, shall remain in full force and effect.

**SECTION 4. Severability Clause.**

If any part, section or subdivision of this Ordinance shall be held unconstitutional or invalid for any reason, such holding shall not be construed to invalidate or impair the remainder of this Ordinance, which shall continue in full force and effect notwithstanding such holding.

**SECTION 5. Effective Date.**

This Ordinance shall become effective upon its adoption or as otherwise required by state law.

### LEGAL DESCRIPTION:

From an angle iron at the Southwest corner of the Southeast quarter of Section 22. Township 4 South, Range 2 East, Baldwin County, Alabama, run thence North 89° 45' 33" East, 1300.28 feet; thence run North 00° 34' 57" East, 54.93 feet to a point on the North right of way line of U.S. Highway No. 31, thence run North 89° 43' 38" East, along said North right of way line, 208.66; thence run North 00° 34' 57" East, 218.64 feet to an iron pin for a Point of Beginning; thence continue North 00° 34' 57" East, 423.86 feet to an elbow iron pipe; thence run South 88° 26' 59" West, 208.78 feet; thence run North 00° 34' 57" East, 35.11 feet to an iron pin; thence run North 00° 45' 10" East, 181.76 feet to an iron pin; thence run North 89° 43' 49" East, 211.50 feet to an iron pin; thence run North 00° 45' 10" East, 208.71 feet to an iron pin; thence run North 89° 43' 49" East, 448.70 feet to an iron pin; thence run South 00° 00' 16" West, 403.26 feet to an iron pin; thence run South 89° 43' 37" West, 219.24 feet to an iron pin; thence run South 00° 00' 12" West, 220.01 feet to an iron pin; thence run South 00° 02' 26" East, 219.35 feet to an iron pin; thence run South 89° 14' 55" West, 242.17 feet to the Point of Beginning.
