Christmas tree recycling will be available at Fire Station One, located at 7580 Spanish Fort Blvd. A roll off dumpster for the placement of trees will be located on the east side of the property, beginning December 19, and will be in place through January 13, 2023.

The City will be partnering with WastePro to place roll-off dumpsters at Spirit Park, located at the end of Emily Frances Lane, beginning on December 19 and continuing through January 3, 2023, for the purpose of recycling paper and cardboard generated from the Holidays. Other forms of trash should not be placed in these dumpsters.

The Spanish Fort Community Center will be closed for the Christmas holidays on December 23, 2022, and December 26, 2022. The Spanish Fort Public Library will also be closed on Christmas Eve, December 24, 2022. The Community Center will be closed on January 2, 2023, for the New Year's Day holiday, and the Library will be closed on December 31, 2022, for New Year's Eve.
