



## **JOB ANNOUNCEMENT ENVIRONMENTALIST**

### **Summary**

The City of Spanish Fort is accepting applications for the position of Environmentalist. Under guidelines set by policy and at the direction of the Mayor and City Council, the Environmentalist is responsible for conducting environmental planning work under the supervision and direction of the Building/Zoning Administrator. This work involves considerable responsibility for collaborating with the Building/Zoning Administrator and other staff in developing long and short-term environmental planning goals and objectives, as well as developing and building an environmental inventory, database, and protection standards for the City, including storm water regulation and inspection. Considerable responsibility for assignments related to plan and review subdivisions and site plans for environmental regulation compliance and completion of those assignments with recommendations. Coordinates grants related to environmental/stormwater projects. Performs other duties as assigned.

**Minimum Qualifications:** Must possess and maintain a valid Alabama driver's license and be insurable by the City's Insurance Provider. Significant graduate-level work completed with major coursework in urban planning, environmental planning, watershed planning, or coastal zone management, with preferably two years' experience in a government setting, and another year's experience in some aspect of either urban and regional planning or natural resource management or protection. Candidates must be willing to work overtime and flexible hours including weekends. **Rate of Pay:** Salary to be determined by qualifications and experience. Salary range is \$49,982.36 to \$79,904.31 per year, depending on experience.
